

## BLYFORD AND SOTHERTON PARISH COUNCIL FREEDOM OF INFORMATION ACT

Information available from the Parish Council under its Publication Scheme

The Parish Council will endeavour to make the information in this definition document available unless:

- *It does not hold the information;*
- *The information is exempt under one of the FOIA exemptions or Environmental Information Regulations exceptions, or its release is prohibited by another statute;*
- *The information is readily and publicly available from an external website; such information will provide a direct link to that information;*
- *the information is archived, out of date or otherwise inaccessible; or,*
- *It would be impractical or resource-intensive to prepare the material for routine release.*
- *The request is vexatious or repeats a previous request from the same person or organisation.*

*The list may not be an exhaustive list and, as a public authority, we will look to provide as much recorded information (emails, electronic, printed or handwritten documents as well as images, videos or audio recordings) as possible. Blyford and Sotherton Parish Council will endeavour to respond to a written request within 20 working days.*

## Publishing datasets

The Datasets Code of Practice recommends that public authorities make datasets available for re-use under the [Open Government Licence](#). Blyford and Sotherton Parish Council will publish any dataset we hold that has been requested, together with any updated versions, unless it is not appropriate to do so. So far as reasonably practicable, we will publish it in an electronic form that is capable of re-use.

The term 'dataset' is defined in section 11(5) of FOIA. The ICO has published [guidance](#) on the dataset provisions in FOIA. This explains what is meant by "not appropriate" and "capable of re-use".
